Instinct Test, Novice, Open, Senior, Master and Crazy 8's

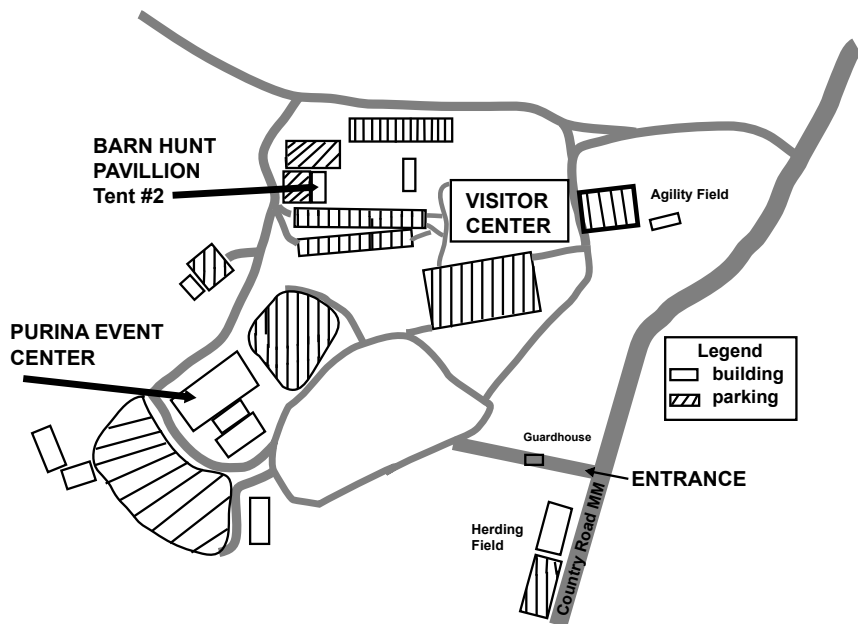


**Entries will open to Norfolk Terriers and Norwich Terriers only on March 5, 2018.** Open to all breeds on March 19, 2018. Entries will be accepted on a first received basis until limits are reached. If limits are not reached by closing (4/20/18) we will accept Late entries until April 25, 2018. Day of Show entries will be accepted. **Crazy 8's will be limited to 25 runs each day. Limit 120 runs per day or 8 hours of Judging per Judge.**

### Judges:

**Susan Chapman (BHAJ-026A) and Mary Newman(BHAJ-172A)**  
Entry fees are \$15 for Instinct, \$25 for Novice, Open and Crazy 8's and \$30 for Senior and Master. Late and DOS Entries are \$20 for Instinct, \$30 for Novice, Open and Crazy 8's and \$35 for Senior and Master.

On both days there will be a short lunch break at the judge's discretion. Move ups will be allowed between trials. **Remember if your dog has passed the Novice title you cannot enter Instinct.**



## EXHIBITOR INFORMATION

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct Test. Dogs completing the RATN in the morning trial either day may be moved up to Open for the second trial. This is up to the handler and not required. Move-ups will be accepted up until 1/2 hour after the conclusion of Trial 1 each day. Move-up forms will be available at the Secretary's table. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or by e-mail.

Make check payable to MCAC. Send entries and fees to the trial Secretary. Dogs must have a Barn Hunt Registration number. Refunds will be made in full if a dog is pulled before 4/20/18 pre-entry closing date but not after - except for a veterinary excuse.

Dogs must have a Barn Hunt registration number. Be aware it may take up to 48 hours to have the number issued. You can auto generate entry forms from the Barn Hunt website. Please be aware of the rules for Barn Hunt trials. Rules may be found at [www.barnhunt.com](http://www.barnhunt.com). All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES, ELECTRONIC COLLARS, PINCH/PRONG COLLARS AND HEAD HALTER-SARE NOT PERMITTED** at the trial site. Please pick up after your dog and dispose of waste in appropriate containers. There is NO SMOKING in the Purina facilities or on the grounds.

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee.

**AWARDS:** Ribbons will be awarded for all qualifiers in the Instinct test and all regular classes. Ribbons will be awarded for first through fourth place for qualifiers in Novice through Master. High in Class ribbons and new title ribbons will also be awarded.

**SPECIAL AWARDS:** Every Norfolk Terrier entering will receive a gift from the Norfolk Terrier Club. All Norfolk Terriers earning a Qualifying score will receive a specialty rosette from the NTC.

Any Norfolk or Norwich terrier that has a qualifying run will receive a Purina Pro Plan 6 Pack Cooler offered by Purina.

Any Norfolk or Norwich terrier that receives High in Trial will receive a Purina Pro Plan Barrel Bag offered by Purina.

These trials will be held outdoors under a pavilion. There is crating space located nearby that is also a covered pavilion. Crating space is first come, first served and will be limited (under the pavilion). Crating in your vehicle is a possibility and might be encouraged depending on time of arrival. There is plenty of green space to crate at the site as well. Please make sure your crate is secure as dogs may be highly excited and the nearby grounds are not fenced in.

**Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/ trial in panties.** Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.
