NOTE: Early entry for Norfolk Terriers and Norwich Terriers ONLY from March 7 through March 22; open to all eligible earthdog breeds for pre-entry from March 23 through April 15 at 6PM CDT. All entries received after that date and time must pay the “Day-Of Test” entry fees.

RUNNING ORDER

Dogs will be run in the order that entries are received with consideration given to dogs being handled by the same handler. The Test Committee reserves the right to modify the running order to keep the event running smoothly.

AWARDS

Light Green Ribbons will be awarded for qualifiers in Introduction to Quarry. Dark Green Rosettes will be awarded for qualifiers in Junior, Senior and Master tests. Title Rosettes are offered by The Norfolk Terrier Club for a new JE, SE or ME or EE title earned at the test.

Each Norfolk Terrier earning a qualifying score will receive a Specialty Rosette offered by The Norfolk Terrier Club.

Each Norfolk Terrier entered in the test will receive a blanket offered by The Norfolk Terrier Club.

Each Norfolk Terrier earning a title (JE, SE, ME, EE) will receive a “free standing glass moon bevel” offered by Jeff Partington and Karen Kotke-Partington in memory of CH Boxcar’s Murphy PA Macallam ME EE CGC

Each Norfolk Terrier and Norwich Terrier earthdog qualifier will receive a Purina Pro Plan small towel offered by Purina.



NOTICE TO EXHIBITORS

Two Tests are being offered on SUNDAY, MAY 6: Event #2018676506 (AM) & Event #2018676507 (PM)

All dogs must be on a short leash under control while on test grounds except while testing. **NO FLEXI-LEADS PERMITTED ON TEST SITE. NO PRONG/CHOKE COLLARS OR GENTLE LEADS.**

Dogs need be present only at the scheduled time of judging according to the judging schedule listed in the premium list.

Master dogs need to be present when their brace is called.

No loose dogs allowed on the grounds outside the judging areas.

Please bring weather-appropriate gear; tests are run rain or shine.

In the event of natural disaster or other circumstances which may deem it too dangerous to safely hold the event, entry fees will not be refunded after the closing time for each class.

No entry fees will be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of the Test Committee.

No entry fees will be refunded for duplicate entries.

Bitches in season are not eligible to compete in Earthdog Tests. Pre-entry fees for bitches that come into season will be refunded until closing time of the class. The refund is of entry fees, less \$10 per test. A veterinarian's certificate must be presented to the Test Secretary prior to the closing of the class for which the bitch is entered. After a class closes, entry fees will not be refunded.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances, repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Test Committee, be asked to leave the test site. In such case, no refund of any fees paid will be made.

Please bring adequate water for you and your dogs as the Visitor's Center and Event Center are a long walk from the earthdog dens. No meals will be offered at this test site; however, the snack bar at the Visitor's Center will be open.

Owners are responsible for errors in completing entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date/time.

Entry forms must be signed at the bottom by the owner or the owner's duly authorized agent, otherwise, entry cannot be accepted.

Incomplete, telephoned, faxed or email entries, entries sent by registered mail, or those made on any form other than an Official American Kennel Club Entry Form cannot be accepted.

For Day-Of (Gate) entries: Be sure to bring the information needed to complete the entry forms. All forms must be complete to be accepted. A copy of the dog's registration certificate contains the necessary information.

OTHER INFORMATION

Introduction to Quarry and Junior Earthdog Class is Open to all dogs. Senior Earthdog class is open only to dogs who have acquired the Junior Earth dog title before the closing of entries. Master Earthdog class is open only to dogs who have acquired the Senior Earthdog title before the closing of entries. Dogs may be entered into only one regular class each day except dogs who have earned the Master Earthdog title.

The safety of the dogs is our primary concern. By entering this test, exhibitors acknowledge that they are familiar with the rules and regulations of this event.

ELIGIBILITY

Dogs must be six months of age or older and be registered with the American Kennel Club. Spayed and neutered dogs, dogs with Limited Registration, and dogs of an eligible breed that have been granted Purebred Alternative Listing /Indefinite Listing Privilege (PAL/ILP) are eligible to participate. Dogs which are blind and deaf shall not be eligible. Bitches in season shall not be eligible to enter the test. All dogs six months of age or older from the breed list below are eligible to participate in these Earthdog Events.

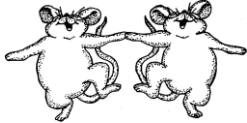
