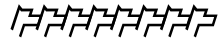

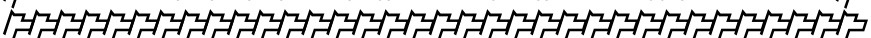

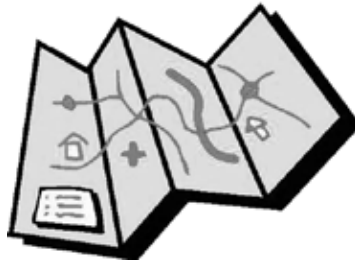

The Pee Wee Event is for children from the ages of 5 to under 9 years of age. Each Pee Wee class consists of the child and a responsible adult which must be in the ring with the Pee Wee. The dog must be at least 4 months of age and have the proper lead and collar. At an All-Breed event, all AKC fully recognized and Miscellaneous Class breeds are allowed to enter, including dogs with a PAL listing. In addition, FSS breeds and All-American dogs may be allowed at the discretion of the Club. The responsible adult is responsible for the control of the dog outside the ring. Clubs must provide an additional lead if the mentor inside the ring feels that it is necessary for the safety of the dog and the Pee Wee. A Release of Liability must be completed before the Pee Wee may enter the Pee Wee Event. For more information on the Pee Wee Event, please refer to the AKC website at:

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

OPEN INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN SENIOR CLASS: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

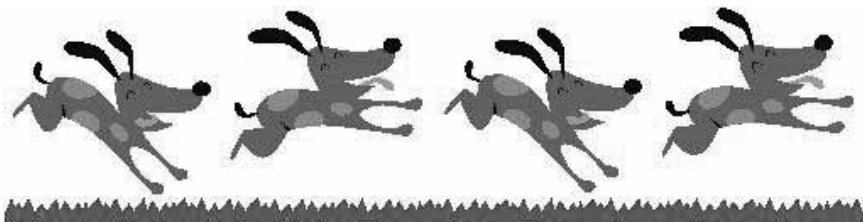

Please be considerate of the amount of space each unit takes. **ELECTRIC MAY NOT BE PIGGY BACKED; WATER MAY BE PIGGY BACKED.** The electrical, water & limited sewer hookups throughout the park are controlled by the North Florida Fairgrounds. The clubs cannot guarantee the functionality or capacity of the available outlets but will make every effort to ensure that all work. To maximize access to water where possible, the clubs suggests the use of water Ts to permit sharing of spigots. Water Ts are not furnished by the clubs; exhibitors must supply their own. It is highly recommended that motor homes bring at least 100 feet of water hose and 100 feet of heavy duty electrical cord. Electrical adaptors may be needed for use of some hookups.

Note: Leveling blocks must be used under jacks to avoid damage to underground water lines.

A Dump Station is available on the grounds at the east end of the midway.

Shower facilities available.

Exhibitors will be responsible for cleaning up their parking areas. When leaving the fairgrounds, please leave your trash in closed garbage bags at your parking site.

Damage to the grounds will be the financial responsibility of the vehicle owner and/or operator.

LIMITED CRATING is available at ringside in buildings #2, #3 & #4 provided that, in the opinion of the Event Committee, no obstruction or safety hazard is created. Crates must be stacked wherever possible and must be removed immediately after completion of that breed's judging.

GROOMING: There will be a 15 minute loading and unloading time limit for vehicles in front. The clubs will require that you leave your vehicle running, lights on and unlocked. If the 15 minute limit is not observed, the vehicle owner risks the vehicle being moved by a club representative or towing. This is necessary for complying with Fire Marshal regulations. Buildings #3 & #6 are the designated grooming buildings. **ALL INSIDE** grooming must be done in buildings #3 & #6. Electricity is available there, but no water. Please conserve grooming space or risk being moved or removed entirely. **See Grooming Reservation Form in this Premium List.**

Dogs may be left in the grooming building overnight, however the grooming building will not be locked. **ALL CRATES MUST BE IDENTIFIED WITH NAME OF OWNER/HANDLER.** All aisles must be left clear. Exhibitors are responsible for keeping their area clean and trash properly disposed of in trash cans located throughout the building.

FOOD SERVICE: Concessions will be available on the grounds.

TROPHIES: The clubs reserve the right to substitute a prize of equal or greater value. **All prizes must be claimed on the day of each show. None will be mailed. All unclaimed prizes become the property of the clubs.**

All unclaimed cash prizes will be added to Best in Show daily.

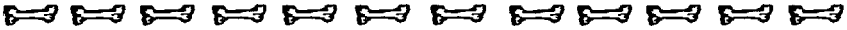

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.50 each additional entry in any Licensed or Member Club Rally Trial. An AKC Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management, it is impossible to open or to complete the event, no refund of entry fee will be made. Class Cash Prizes will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Superintendent's Office advised at once. The Superintendent and Show-Giving Club disclaim any liability for cash prizes after the judging of the breed is over.
